



PERSONAL DATA PROTECTION LAW (KVKK)

As **Newtone Gas Springs** ® **Avie Foreign Trade And Industry, LLC** protecting the confidentiality of our customers', suppliers', employees', and job candidates' personal data, ensuring and maintaining information security are among our primary principles.

Information Regarding the Protection of Personal Data

Under the Law on the Protection of Personal Data No. 6698 (referred to as the "Law"), your personal data (such as your gender and interests) and special categories of personal data (such as information about union/association/foundation memberships, criminal convictions, marital status, sexual life, biometric data, and health information) that you share with our company will be stored, recorded, updated, disclosed/transferred to third parties when permitted by legislation, classified, and processed in accordance with the Law by our company.

Purposes and Transfer of Personal Data

Your processed personal data may be transferred to relevant authorities without the need for notification and consent under Article 28/1 of the Law upon request.

In unforeseeable situations, your personal data may be transferred to public institutions specified by law (such as ministries, presidential boards, and other administrative authorities) within the purposes and limitations prescribed by the law if requested.

Currently, there is no such foreseeable situation, and you will be informed in advance if this occurs.

Additionally, for the requirements of contracts, to ensure the full, correct, and timely provision of services, and to address requests and complaints, your personal data is shared with sectoral associations and **Newtone Gas Springs** ® **Avie Foreign Trade And Industry, LLC** affiliates and service providers (partners).

Except for our legal obligations where notification and consent are not required, your personal data is not transferred to any real or legal persons, institutions, or organizations.

Your Rights as a Data Subject:

As the data controller, you can apply to **Newtone Gas Springs** ® **Avie Foreign Trade And Industry, LLC** regarding the processing of your personal data and exercise the following rights:

- a. To learn whether your personal data is processed,
- b. To request information if your personal data has been processed,
- c. To learn the purpose of processing your personal data and whether it is used in accordance with its purpose,
- d. To know the third parties to whom your personal data is transferred domestically or abroad,
- e. To request correction of your personal data if it is incomplete or incorrectly processed,

- f. To request the deletion or destruction of your personal data within the conditions specified in Article 7 of the Law,
- g. To request notification of the actions taken pursuant to subparagraphs (d) and (e) to third parties to whom your personal data has been transferred,
- h. To object to the processing of your personal data exclusively by automated means that result in an unfavorable outcome for you, and
- ı. To request compensation for damages if you suffer harm due to unlawful processing of your personal data.
